Building Search Committee Report

The contract of sale, long pending on the Marina property, has failed to acquire necessary mortgage loans, and per Jerry Wright, Managing Partner of the Sabine Marina LLC, the deal has failed and the prospective buyers have discontinued all effort to close. The deal is dead. -----That means PBYC is back where it started two years ago when we signed a five-year lease on our current home. We have the right to use the leased clubhouse until April 30, 2015 and the obligation to pay rent on it until that time. Since the LLC has been trying to sell the property since 2009, our lease was predicated on a written "escape clause." That clause states that if the LLC finds a buyer, and if that buyer wants to use our space, we can be given 90 days written notice to quit the premises from the time the closing documents are signed. In reality that means we have about six months to find another home from the time a serious prospect shows up, signs a contract, performs due diligence, closes on the property, and sends us a letter. At the present time there are no offers on the table. Rumors will abound. Nothing has changed. We have been living on rumors for the 13 years I have been a member. It is the responsibility of my committee to give you and the Board of Directors immediate notice if any legal offer is made and accepted. That we shall do.-----Should the day arrive when we are forced to leave or want to leave in April 2015, my committee's responsibility is to keep current an inventory of properties that we could immediately act on and make an offer for, either to buy, or lease-purchase, or just lease. For instance, there are at this moment, two locations on Pensacola Beach of great interest to us, and several others in Gulf Breeze that are less desirable. Of course we have a lease until 2015, but if that ever changes, we will go into action. I will keep members advised monthly via the Spreader and if you wish, you can speak to me personally at the club each Wednesday or Friday. I will be the person drinking scotch from a real glass.
