Vice Commodore's Report

Lisa Sharp resigned as Project Manager of the Building project on April 15, 2016 and transferred all documents and responsibility to the Board on April 20, 2016. On that date the Board had its second meeting in April with the builder, Mike Haile, and drafted a memorandum of understanding regarding a future timeline of building activities. All of this information has been previously emailed to every member household twice in April and has been published on the Club website pensacolabeachyachtclub.org under the Blog Post box "Building updates".

Members are urged to refer to the website for the most up to date news on the building.

Key dates verbally agreed to by the Board and builder include final building plans ready for County, April 30; Approval by County, May 10; Ordering of pilings May 12; Final permitting of all subs June 1; Begin construction June 2; Completion 4 to 5 months thereafter.

Without a project manager, the Board is assuming control by frequent contact with the builder through the Vice Commodore who has been assigned to update members in writing at least every 14 days and to update the Board daily if necessary.

PROPOSED BYLAW CHANGES

The following changes to the PBYC bylaws have been proposed by the Board of Directors. Members can vote for or against these changes at the May 12, 2016 membership meeting. If you cannot attend, you will be able to vote (one vote per household) online using a link that will be sent to you via email.

Background. Recent purchase of land and construction thereon obsoletes certain bylaw language. Members are asked to vote on these language changes to keep the bylaws up to date.

Item 1. Delete Art. 21. Current article shown below is now obsolete as we no longer have a Morgan Keegan account.

21. CLUBHOUSE FUND.

The clubhouse fund consists of the proceeds of the Morgan Keegan shares account and are owned by the donating members.

Item 2. Re-number Art. 22 to 21

Item 3. Re-number Art. 23 to 22

Item 4. Re-numbered Art. 21 ---Replace the existing Art. 21 Language with: “ The building fund exists to accumulate funds from initiation fees, fund raising activities, and gifts which can be used by the board from time to time to improve the club facilities.”

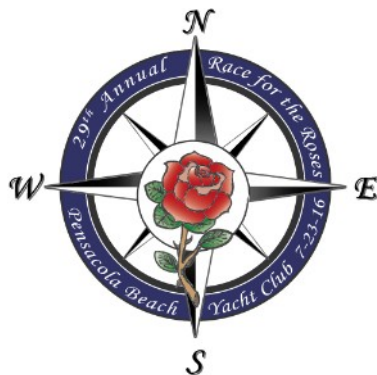
